OR A DRUG-RELATED CRIME (OR PERHAPS BOTH). DURING THE LAST FEW DAYS, THE LOCAL PRESS PUBLICIZED THAT MRS. VAZQUEZ WAS THE OWNER OF A MASSAGE PARLOR WITH A BAD REPUTATION FOR INVOLVEMNET IN CRIMINAL ACTIVITIES. HOWEVER, POLICE DENY THAT INFORMATION. REMAINS WERE FOUND AT QLOTE BRAVOQ, A PLACE WHERE THE BODIES OF OTHER MURDERED WOMEN HAVE BEEN FOUND IN THE PAST. POST HAS CONTACTED NOK AND PROVIDED HER WITH INFORMATION ON SHIPMENT OF REMAINS TO THE U.S FROM CIUDAD JUAREZ AND HOW TO OBTAIN A RODAC. CHECKS WITH SOCIAL SECURITY INDICATE THAT THE VICTIMQS YOUNGEST CHILD MAY QUALIFY FOR BENEFITS, INFORMATION RELAYED TO THE NOK. ACCORDING TO NOK, VICTIM WAS A DRUG DEALER. SHE WAS REPORTEDLY THE GIRLFRIEND OF A KNOWN DRUG DEALER WHO WAS RELEASED FROM PRISON JUST ONE DAY BEFORE HER MURDER. VAZQUEZ
