IS THE DISCOVERY OF THE REMAINS OF EIGHT WOMEN
MURDERED AND BURIED IN A DRIED COTTON FIELD
LOCATED IN A POPULATED AREA OF JUAREZ (REFTEL).
CLOTHING FROM ONE OF THE VICTIMS HAS BEEN IDENTIFIED
AS BELONGING TO CLAUDIA IVETTE GONZALEZ, 20, WHO
DISAPPEARED ON OCTOBER 10 AFTER LEAVING WORK
AT A LEAR CORPORATION TWIN PLANT. AUTHORITIES ARE
DOING DNA AND ODONTOLOGICAL TESTING TO POSITIVELY
ESTABLISH IF THE VICTIM IS INDEED CLAUDIA IVETTE
GONZALEZ. THE ESTIMATED TIME OF DEATH FOR THE
REMAINING VICTIMS HAS BEEN ESTABLISHED AT OVER A
MONTH AGO.
