OPERATOR ASSISTANCE

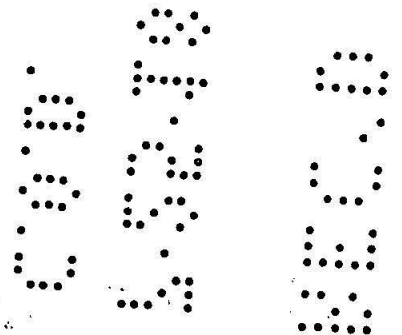
