

## **Ed.Flicks – Library Subscription License Agreement**

This Licensed Product Agreement (“Agreement”) is between **Exchange Press**, a division of Dimensions Educational Research Foundation (“Licensor”), with a principal place of business at 7733 A Street, Lincoln, NE 68510, and College of DuPage (“Licensee”), with a principal place of business at 425 Fawell Blvd, Glen Ellyn, IL 60137.

### **Scope**

- The entire contents of Ed.Flicks are copyrighted materials that are licensed to Licensee for use subject to the terms and conditions of this License Agreement (“Agreement”).
- Upon submission of a signed Agreement and payment of the subscription fee, Licensor grants to the Licensee a non-exclusive, non-transferable license for access to all materials included in Ed.Flicks through a secure network. An authorized signature on this Agreement indicates that Subscriber has accepted the terms of this license.
- Licensor reserves the right to update this Agreement at the time of renewal.
- Licensor may terminate this Agreement for substantial or material breach of the Agreement by providing Licensee with written notice in paper or electronic form. No refund will be provided upon such termination.

### **Access**

- This Licensee and its Authorized Users shall be granted access to Ed.Flicks using one or more of the following as outlined in Exhibit A: Internet Protocol (“IP”) addresses, unique URL, or direct individual login. Authorized Users shall be identified and authenticated using information provided by the Licensee to the Licensor in Exhibit A.
- Control over authentication of users is the responsibility of the Licensee.
- Licensee will use reasonable efforts to notify Authorized Users of the terms and conditions of this Agreement applicable to them.
- Licensee is responsible for undertaking reasonable measures to prevent access by unauthorized or unauthenticated persons, and Licensee will be responsible for any unauthorized access and any resulting downloading or reproduction.

### **Authorized Users**

- For purposes of this Agreement, Authorized Users of Ed.Flicks are outlined in Exhibit A.

### **Copyright**

- Copyright of Ed.Flicks and its entire contents are owned by Licensor, except when third party copyright is noted on content.
- Any other use, duplication, or distribution of Ed.Flicks or its contents in any medium and by any means violates applicable U.S. and international copyright laws and treaties, and you may be subject to prosecution and penalty of law.
- Misappropriation for commercial use or further distribution is strictly prohibited.

### Permitted Use

- Any Authorized User may: search and view individual videos or other items from Ed.Flicks with other Authorized Users and/or for private personal use or research. Download access may be available to a subset of Authorized Users according to terms outlined in Exhibit A.
- Authorized Users granted download access may view videos from Ed.Flicks with other individual Authorized Users under this Agreement. If the subscription is not renewed, all copies of the Licensed Content must be deleted from all storage locations including, but not limited to, computers/laptops, mobile devices, external hard drives, other external storage devices, and learning management systems.
- Authorized Users granted download access may post any videos included in Ed.Flicks in a password protected learning management system provided that the materials are distributed only to individuals enrolled in the training/course; materials are not made available for download; no charge is made for access to the materials; materials are not made or distributed for commercial advantage; and that the items bear the appropriate Exchange and third party copyright notices.

### License Term

- The license term will begin when this signed agreement and payment of the license fee are received by Exchange Press. The initial license term shall be for one year unless otherwise indicated in Exhibit A.
- This Agreement is renewable on an annual basis for four (4) successive one-year periods (each, a "Renewal Term") and is effective for as long as the Licensee maintains an active, paid account and does not violate the terms of the Agreement.

### Restrictions on Use of Licensed Content

- Except as specifically provided elsewhere in this Agreement, the Licensee shall not knowingly permit anyone other than Authorized Users to use the Licensed Content.
- Neither the Licensee nor any Authorized User shall modify, adapt, abridge, or create a derivative work of the Licensed Content without the prior written permission of the Licensor.
- The Licensee may not remove, obscure, or modify presenters' names or copyright notices included in the Licensed Content nor any metadata or digital rights management information that may be associated with the Licensed Content.
- Other than as specifically permitted in this Agreement, neither the Licensee nor any Authorized User may use the Licensed Content for Commercial Use.
